ADMISSION PROCEDURE

1. Candidates with minimum 55% marks at Masters Level in respective subject of Ph.D are only eligible for appearing in entrance test.
2. **a)** Entrance test will be conducted by KSV for Ph.D admission.
 - b) Exemption from Entrance Test:**
 - Qualified in SLET/NET/JRF examinations of bodies such as CSIR, UGC, etc. in relative subjects shall be exempted from entrance test subject to verification of relevant certificates & other documents.
 - M.Phil. degree from Kadi Sarva Vishwavidyalaya
 - M.Phil. degree candidates from another statutory University whose admission at M.Phil. has been done through an entrance test.
 - Candidate who appeared in the latest GATE and have scored more than 75 percentile or 75 per cent score.
 - c)** Minimum passing level in Entrance Test is 50% marks.
 - d)** A personal interview by Subject Experts (RDC) will be conducted before granting the admission.
 - e)** At the time of interview, the doctoral candidates are expected to discuss their Research-interest/area.
 - f)** The title of the thesis once approved shall not be changed except on the recommendations of the Supervisor and with the permission of the RDC.
 - g)** (d),(e) & (f) above are applicable to the candidates exempted from (b) above also.
 - h)** Only pre-determined number of students will be admitted to Ph.D programs.
 - i)** The selected candidates after the process of Entrance Exam and Personal Interview shall be enrolled provisionally and they should complete the course work as designed by the University and upon successful completion of course work only they shall be given the final enrollment letter.
3. Admission to the Ph.D program would be direct and not through M.Phil.
4. **Admission of Foreign Students:** Foreign applicants will be considered if they are recommended by the Ministry of External Affairs, Government of India. The foreign nationals must produce a valid research visa at the time of seeking admission to the Ph.D program. If admitted, they will be governed by such rules and regulations as may be framed by the Government of India and by the authorities of the University from time to time.
5. Gujarat State Government's **Reservation policy** will be followed in accordance with the needs - based on applications received from notified categories seeking admission under reservation rules, number of vacancies etc. Such candidates will have to attach caste certificate. SEBC/OBC Candidates seeking reservation benefit for admission should attach valid creamy layer certificate.

6. **Duration** of Course: Ph.D – All subjects (Minimum 3 years).
7. **Research Proposal & Relevant documents must be submitted with the application form failing which your application will be rejected.**
